**RESOLUTION NO. 2020-072**

**A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF WILTON MANORS, FLORIDA, ADOPTING THE FINAL BUDGET FOR THE FISCAL YEAR BEGINNING OCTOBER 1, 2020, AND ENDING SEPTEMBER 30, 2021; DETERMINING AND FIXING THE AMOUNTS NECESSARY TO CARRY ON THE GOVERNMENT OF THE CITY FOR THE ENSUING YEAR; PROVIDING FOR SEVERABILITY, CONFLICTS, AND AN EFFECTIVE DATE.**

13           **WHEREAS**, on September 14, 2020, the City Commission of the City of Wilton  
14 Manors, Florida adopted Resolution No. 2020-066, adopting a tentative budget for the fiscal  
15 year beginning October 1, 2020 and ending on September 30, 2021; and

16           **WHEREAS**, a final budget has been prepared by the City Manager estimating  
17 expenditures and revenues of the City for the ensuing year, with detailed information,  
18 including revenues to be derived from sources other than ad valorem levy, and she has made  
19 recommendations as to the amount necessary to be appropriated for the ensuing year; and

20           **WHEREAS**, the City Commission of the City of Wilton Manors has conducted  
21 public hearings and has considered the recommendations, the final budget, and the final  
22 millage necessary to be levied to carry on the government of the City for the ensuing year.

23           **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION**  
24 **OF THE CITY OF WILTON MANORS, FLORIDA:**

25           **Section 1:** Each "WHEREAS" clause set forth above is true and correct and  
26 incorporated herein by this reference.

27           **Section 2:** That the final budget of the City of Wilton Manors, Florida, for the  
28 fiscal year beginning October 1, 2020, and ending September 30, 2021, is hereby adopted  
29 and the appropriations set out therein are hereby made to maintain and carry on the  
government of the City of Wilton Manors, Florida. A copy of the tentative proposed budget

1 is attached hereto as **Exhibit "A"**. There is hereby appropriated the sum of \$18,005,627.00  
2 to the General Fund for the payment of operating expenses and necessary capital outlays for  
3 the City Government pursuant to the terms of the above tentatively proposed budget.

4 **Section 3:** The City Manager, or designee, is hereby authorized to comply with  
5 Section 200.065, including, but not limited to delivering this Resolution and other necessary  
6 documentation to the property appraiser, tax collector and the State.

7 **Section 4:** All delinquent taxes collected during the ensuing fiscal year as  
8 proceeds from levies of operation millages of prior years are hereby specifically  
9 appropriated for use of the General Fund.

10 **Section 5:** If any clause, section or other part of this Resolution shall be held by  
11 any court of competent jurisdiction to be unconstitutional or invalid, such unconstitutional  
12 or invalid part shall be construed as eliminated and shall in no way affect the validity of the  
13 remaining portions of this Resolution.

14 **Section 6:** All Resolutions or parts of Resolutions in conflict herewith are  
15 hereby repealed to the extent of such conflict.

16 **Section 7:** This Resolution shall become effective immediately upon passage.




