RESOLUTION NO. 2021-072

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF WILTON MANORS, FLORIDA, AMENDING RESOLUTION NO. 2020-072 TO AMEND AND APPROPRIATE ADDITIONAL FUNDING FOR THE FISCAL YEAR 2020/21 BUDGET; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

10 **WHEREAS**, Resolution No. 2020-072 appropriated funds based on an annual budget of
11 estimated revenues and expenditures for the 2020/21 Fiscal Year; and

12 **WHEREAS**, connection fees have been collected during prior fiscal years and
13 reserved for future use for Sewer purposes; and

14 **WHEREAS**, the available amount of reserved Sewer Connection Fees is
15 \$397,630.40 as of September 30, 2020; and

16 **WHEREAS**, capital outlays have been identified during Fiscal Year 2020/21 as having
17 Sewer purposes; and

18 **WHEREAS**, the City Commission of the City of Wilton Manors finds that these
19 appropriations of previously reserved connection fees to fund certain Sewer capital outlays
20 constitute a proper public purpose; and

21 **WHEREAS**, Resolution No. 2020-072 is amended to reflect capital outlays to be
22 funded through connection fees during Fiscal Year 2020/21 pursuant to Exhibit "A", attached
23 hereto and incorporated herein.

24 **NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF**
25 **THE CITY OF WILTON MANORS, FLORIDA, THAT:**

26 **Section 1.** The foregoing "WHEREAS" clauses are hereby ratified and confirmed
27 as being true and correct and are hereby made a specific part of this Resolution.

Section 3. All resolutions or parts of resolutions in conflict herewith, be and the same are repealed to the extent of such conflict.


