

1 market changes and community needs; assisting in improving the sales and occupancy rates;
2 funding physical improvements; providing for pedestrian safety; marketing the district;
3 increasing parking opportunities for visitors and shoppers; fielding special events and street
4 celebrations; and including paying the costs necessary and incidental thereto through non-ad
5 valorem assessments; and

6 **WHEREAS**, the City Commission has reviewed factors set forth in Chapter 189,
7 Florida Statutes, and upon such review has determined that the establishment of the District is
8 in the best interest of the City and its residents for their existing and future health, safety and
9 welfare.

10 **NOW, THEREFORE, BE IT ORDAINED BY THE CITY COMMISSION OF THE CITY**
11 **OF WILTON MANORS, FLORIDA, AS FOLLOWS:**

12
13 **SECTION 1.** The foregoing recitals are hereby ratified and confirmed as being true and
14 correct and are hereby made a specific part of this Ordinance upon adoption hereof.

15 **SECTION 2. Establishment of District.** The City does hereby establish the Wilton
16 Drive Improvement District, hereinafter the "District" as a dependent special district within the
17 meaning of Chapter 189, Florida Statutes, for all purposes consistent with, and as authorized by
18 Chapter 189, Florida Statutes and all other applicable laws.

19 **SECTION 3. Establishment of District Boundaries.** The geographic boundaries for the
20 District shall include and incorporate all property described in Exhibit "A", a copy of which is
21 attached hereto and incorporated herein by reference, all lands of which are located within the
22 municipal boundaries of the City.

23 **SECTION 4. Purpose, Powers, Functions, Duties and Authority of District.** The
24 District shall have all powers as authorized by Law, to effectuate its purpose to include but not
25 limited to: improve, maintain, and fund physical improvements; provide for pedestrian safety;

1 market the District; increase parking opportunities for visitors and shoppers; field special
2 events and street celebrations; provide for the construction, reconstruction, repair, paving,
3 repaving, hard surfacing, rehard surfacing, widening, guttering, and draining of streets,
4 boulevards, and alleys; grading, regrading, leveling, laying, relaying, paving, repaving, hard
5 surfacing, and rehard surfacing of sidewalks; for constructing or reconstructing permanent
6 pedestrian canopies over public sidewalks; and in connection with any of the foregoing,
7 provide related lighting, landscaping, street furniture, signage, and other amenities as
8 determined by the City Commission of the City of Wilton Manors; order the construction,
9 reconstruction, repair, renovation, excavation, grading, stabilization, and upgrading of
10 greenbelts, swales, culverts, sanitary sewers, storm sewers, outfalls, canals, primary, secondary,
11 and tertiary drains, water bodies, marshlands, and natural areas, all or part of a comprehensive
12 stormwater management system, including the necessary appurtenances and structures thereto
13 and including, but not limited to, dams, weirs, and pumps; order the construction or
14 reconstruction of water mains, water laterals, alternative water supply systems, including, but
15 not limited to, reclaimed water, aquifer storage and recovery, and desalination systems, and
16 other water distribution facilities, including the necessary appurtenances thereto; pay for the
17 relocation of utilities, including the placement underground of electrical, telephone, and cable
18 television services, pursuant to voluntary agreement with the utility, but nothing contained in
19 this paragraph shall affect a utility's right to locate or relocate its facilities on its own initiative
20 at its own expense; provide for the construction or reconstruction of parks and other public
21 recreational facilities and improvements, including appurtenances thereto; provide for the
22 construction or reconstruction of seawalls; provide for the drainage and reclamation of wet,
23 low, or overflowed lands; provide for offstreet parking facilities, parking garages, or similar

1 facilities; provide for mass transportation systems; provide for improvements to permit the
2 passage and navigation of watercraft; and provide for the payment of all or any part of the costs
3 of any such improvements by levying and collecting special assessments on the abutting,
4 adjoining, contiguous, or other specially benefited property; and to provide access to the
5 businesses located within the boundaries of the District, and such other improvements and
6 appurtenances within the District as may be necessary for the improvement, maintenance,
7 monitoring and providing of access to such businesses. However, offstreet parking facilities,
8 parking garages, or other similar facilities and mass transportation systems must be approved
9 by vote of a majority of the affected property owners.

10 In addition, as necessary to effectuate its purposes as set forth herein, the District shall
11 have the following powers:

12 a. The right to exercise any and all provision or powers granted to the District by
13 applicable law;

14 b. The full and complete right to contract, subject to the limitations set forth herein;

15 c. The authority to prescribe, fix, maintain and regulate fees, charges or rents for
16 the use of any District facilities or services;

17 d. With the prior approval of the City by a resolution of the City Commission, to
18 borrow money, issue bonds and other types of securities, pledge or otherwise encumber any
19 of the District's property or assets upon terms and conditions to be determined by the District
20 Board, subject to approval by resolution of the City Commission;

21 e. The right to adopt and enforce reasonable rules and regulations or procedures
22 pertaining to the use, acquisition, maintenance, development, operation or disposal of any of
23 the properties, services, facilities, or projects of the District;

1 f. The right to do, and to perform all such things separately or in conjunction with
2 a county, municipality, other special districts or other political subdivision of the state whether
3 the same is within or without the territorial limits of the District, subject to approval by the City
4 Commission;

5 g. The authority to employ a staff and such other technical assistants and other
6 employees as the District Board shall determine to be necessary;

7 h. The right to conduct and pay for studies, plans and designs to effectuate the
8 purpose of the District, which action may include, but is not limited to, work plans for
9 expansion, staffing plans and financing plans;

10 i. The right to enter into interlocal agreements or other contracts with the City, if
11 necessary, for the purpose of accomplishing the purposes of the District;

12 j. The right to enter into contracts with public or private entities for the provision
13 of assistance in planning, financing and constructing any and all facilities and services as
14 determined to be appropriate and desirable by the District Board;

15 k. The right to contract for appropriate engineering and financial feasibility studies;

16 l. The right to maintain an office at such place or places within the
17 territorial boundary of the District as the District Board may designate;

18 m. The right to employ and compensate such personnel, consultants and technical
19 and professional assistants as the District Board shall deem necessary to the exercise of the
20 District powers and to the performance of the duties set forth in this Section;

21 n. The right to accept and receive, utilize or expend, in furtherance of its functions,
22 funds, grants and services from the federal government or its agencies, from departments,
23

1 agencies and instrumentalities of state, municipal, county or other local governments, or from
2 private or civic sources;

3 o. The right to invest in accordance with applicable Florida law any surplus
4 money, including such money in any sinking fund or other fund established for the
5 purpose of providing for the payment of the principal or interest of any bonded or other
6 indebtedness or for any other purpose;

7 p. The right, subject to the approval of the City Commission, to assess and impose
8 upon real property in the District non-ad valorem assessments; and to charge, collect, and
9 enforce fees and other user charges pursuant to Chapter 197, Florida Statutes. The District's
10 non-ad valorem assessment authority shall be limited to the sum of \$100,000.00 per year.
11 Notwithstanding the foregoing, the District shall not assess or charge, collect or enforce fees or
12 other charges upon real property owned by any Federal, State or local governmental entity;

13 q. The right to hold, control, and acquire by donation or purchase, or dispose of,
14 any easements, dedications, platted reservations, or any reservations for those purposes
15 authorized by this Ordinance and to make use of such easements, dedications, or reservations
16 for any of the purposes authorized by this Ordinance;

17 r. The right to hold, control and acquire by donation or purchase, or dispose of,
18 any District property for those purposes authorized by this Ordinance and to make use of
19 such property for any of the purposes authorized by this Ordinance.

20 s. The right to have and exercise such powers as are reasonably implied in or not
21 inconsistent with this Ordinance and which the District Board determines are necessary and
22 proper to carry out the objectives and purposes of the District.

23

1 **SECTION 5. Governing Board of District.** The governing body of the District, shall be
2 designated as the Board of Supervisors (the "District Board"), and shall be appointed by the
3 City Commission. There shall be staggered terms for members of the District Board. At the
4 City Commission Meeting at which initial District Board appointments are made, three (3)
5 board members shall be appointed for an initial two (2) year term, and four (4) board members
6 shall be appointed for an initial three (3) year term. Appointments to the District Board shall
7 serve at the pleasure of the City Commission but unless otherwise stated in the appointment,
8 the members of the District Board shall, after the initial terms, serve for a term of three (3)
9 years from the date of appointment. Any vacancy in the District Board shall be filled by an
10 appointment made by the City Commission for the balance of the unexpired term within sixty
11 (60) days of the occurrence of such vacancy. The District Board shall exercise the powers
12 granted to the District. The District Board shall consist of seven (7) members, three (3) of
13 which are the owners of real property within the District, three (3) of which are tenants having
14 their business located within the District and one (1) resident of the City of Wilton Manors that
15 owns and resides within a homestead property within the geographic boundary of the City
16 created by Andrews Ave., Dixie Highway, the Middle River and 26th St. Each member shall
17 hold office until a successor is chosen. In the event a property owner or business owner
18 within the District is a corporation or a Limited Liability Company, the Board member shall be
19 an officer of the corporation or a member or manager of the Limited Liability Company. No
20 District Board member shall be affiliated with another. Although the District has multiple
21 property owners and business owners working in the same building or area and may on
22 occasion engage in collaborative activities for the welfare of the District, no District Board
23 member shall have an ownership interest, business interest, employment relationship or

1 landlord tenant relationship with any other District Board member or principal of any other
2 board member.

3 A majority of the members of the District Board shall constitute a quorum for the
4 purposes of conducting its business and exercising its powers and for all other purposes. The
5 procedures of the District Board shall be governed by the latest revised version of Robert's
6 Rules of Order. Action taken by the District Board shall be upon a vote of a majority of the
7 members present unless general law or a rule of the District requires a greater number. The
8 District Board shall keep a permanent record book in which shall be recorded minutes of
9 all meetings, resolutions, proceedings, certificates, bonds, and any and all corporate acts.
10 The record book shall at reasonable times be opened to inspection in the same manner as state,
11 county, and municipal records pursuant to Chapter 119, Florida Statutes. The record book shall
12 be kept at the office or other regular place of business maintained by the District Board.

13 The District Board shall elect one member as chairperson and one member as vice-
14 chairperson. The chairperson shall preside at Board meetings and execute all contracts and
15 other legal documents on behalf of the District. The chairperson shall be elected for the term of
16 one (1) year. If the chairperson shall cease to be a member or shall for any reason be unable to
17 serve as chairperson, a successor shall be elected by the District Board for the unexpired
18 portion of the term. The vice-chairperson shall be elected for a term of one (1) year and shall
19 have all of the duties of the chairperson in his/her absence. If neither the chairperson nor vice
20 chairperson is in attendance and willing to chair a meeting at which a quorum is present, the
21 District Board may elect a chairperson pro-tem for the duration of that meeting.

22 All powers, privileges and duties vested in or upon the District shall be exercised and
23 performed by and through the District Board; provided, however, the exercise of any and all

1 executive, administrative and ministerial powers may be delegated by the District Board to any
2 of its officers, staff, employees, agents or designees, which delegation may be re- delegated or
3 withdrawn by the District Board. The District Board shall fix and publish the time and place or
4 places at which its regular meetings shall be held, and shall provide for the calling and holding
5 of special meetings at the request of any supervisor upon appropriate notice. The District
6 Board shall adopt rules, regulations, resolutions, and orders for conducting its business.

7 District Board Members shall be subject to all ethics requirements in the City Code,
8 including but not limited to the cone of silence and lobbyist registration and reporting
9 requirements set forth in Sections 2-268 and 2-352 - 2-358 of the City Code, as amended.
10 District Board members shall serve without compensation, but shall be reimbursed for per diem
11 and travel in accordance with Section 112.061 Florida Statutes, as amended, or other applicable
12 Florida law.

13 **SECTION 6. Financing of the District.** Subject to the provisions of Section 4 hereof,
14 the District, in order to finance the purposes and operations of the District, shall have the power
15 to borrow money and issue bonds, revenue anticipation notes, or certificates payable from and
16 secured by a pledge of funds, revenues, and assessments, warrants, notes, or other evidence
17 of indebtedness; and to cooperate or contract with other persons or entities, including other
18 governmental agencies as necessary, convenient, incidental, or proper in connection with
19 furthering any power, duty, or purpose authorized by applicable law and to take any other
20 action not inconsistent with applicable law.

21 **SECTION 7. Non-ad valorem assessments.** Pursuant to Chapter 197, Fla. Stat., non-
22 ad valorem assessments levied pursuant to this Ordinance shall remain liens, coequal with the
23

1 lien of all state, county, district, and municipal taxes, superior in dignity to all other liens, titles,
2 and claims until paid.

3 **SECTION 8. Consistent with Comprehensive Plan and District as the Best Alternative.**

4 The creation of the District is consistent with the City of Wilton Manors' Comprehensive Plan
5 and all other applicable growth management rules, regulations, ordinances, and laws. The
6 District is the most efficient and effective method by which to achieve the purposes set forth
7 above (as opposed to private alternatives such as a property owner's association, private
8 partnership, neighborhood association, or public alternatives such as MSTU, MSBU, special
9 independent district, etc.).

10 **SECTION 9. Applicable Financial Disclosure, Noticing, and Reporting Requirements.**

11 The District will provide all financial disclosures required by Florida law relating to dependent
12 special districts, including but not limited to, all financial disclosures relating to bonds,
13 financing, non-ad valorem special assessments, and the like. Any and all meetings of the
14 District Board shall be noticed in accordance with Chapter 286, Florida Statutes, as amended.
15 Any and all notices that are required to be provided to the landowners within the District shall
16 be provided by U.S. Mail delivery or by posting public notice in a designated area within the
17 District, which area shall be specified by the District Board. The District will comply with all
18 reporting requirements required by Florida law relating to dependent special districts.

19 **SECTION 10. Budget and Approval Thereof.** On or before each April 15, the District
20 Board shall prepare or have prepared under its direction a proposed budget for the ensuing
21 fiscal year. The proposed budget shall include an estimate of all necessary expenditures of the
22 District for the ensuing fiscal year and an estimate of income to be received by the District for
23 such ensuing fiscal year. The budget shall be balanced; that is the total of the estimated

1 receipts including any balances brought forward shall at least equal the estimated expenditures.
2 No later than each May 1, such proposed budget shall be delivered to the City Manager of the
3 City. The budget for the District shall be subject to review and approval by the City
4 Commission. If the City Commission approves the District's budget, it shall approve and adopt
5 the budget no later than September 30.

6 **SECTION 11.** Conflicts. That all Ordinances or parts of Ordinances, Resolutions
7 or parts thereof in conflict herewith, be and the same are hereby repealed to the extent of such
8 conflict.

9 **SECTION 12.** Severability. Should any section, provision, paragraph, sentence, clause of
10 word of this Ordinance or portion hereof be held or declared by any court of competent
11 jurisdiction to be unconstitutional or invalid, in part or application, it shall be considered as
12 eliminated and shall not affect the validity of the remaining portions or applications of this
13 Ordinance.

14 **SECTION 13.** Sunset Provision. This Ordinance shall automatically sunset ten (10) years
15 from the effective date hereof, unless otherwise extended.

16 **SECTION 14.** Effective Date. This Ordinance shall become effective upon adoption.







- (a) Subject:** City Commission approval on second reading and public hearing of Ordinance No. 2014 - 0011 to approve the creation of a Wilton Drive Improvement District, a dependent special district authorized by Section 189.02, Florida Statutes.
- (b) City Manager Recommendation:** Recommends approval of Ordinance No. 2014 – 0011 approving the creation of the Wilton Drive Improvement District.
- (c) Report in Brief:** The attached Ordinance was prepared in accordance with prior discussions with the City Commission, staff-based research, professional knowledge of City of Wilton Manors' needs and discussions with the Economic Development Task Force. The proposed Ordinance seeks to achieve the goals of the City by increasing public parking, providing needed services and increasing the tax base.
- (d) Discussion:** The goal of the Wilton Drive Improvement District would be to help stabilize and improve the Arts and Entertainment District by creating a unified strategy for development and to improve the public right-of-way for pedestrian activity.

The Wilton Drive Improvement District is proposed to be a public/private partnership in which stakeholders make a collective contribution to the improvement, maintenance, development and/or promotion of the commercial district. Funds would be raised to supplement baseline City Services, district marketing to attract visitors and tourists, or enhancement of Capital Improvements to enhance the pedestrian scope of Wilton Drive.

The Wilton Drive Improvement District will be created with an independent Board of Directors responsible for creating and directing the overall strategy for improvement along the Arts and Entertainment District corridor.

The financing for the Wilton Drive Improvement District is proposed to come from a Special Assessment to fund the enhanced services.

(e) Strategic Plan Consistency: Goal 1: Sustainable Urban Village, Objective 3: Livable Neighborhoods Integrating Commercial and Residential.

(f) Concurrences: Economic Development Task Force

(g) Fiscal Impact: The outcome of a successful proposal and the implementation of a Public-Private Partnership will result in an increase in the local tax base.

(h) Alternatives: None suggested
