RESOLUTION NO. 2023-037

A RESOLUTION OF THE CITY COMMISSION OF THE CITY OF WILTON MANORS, FLORIDA, AMENDING RESOLUTION NO. 2022-091 TO APPROPRIATE ADDITIONAL FUNDING FOR THE FISCAL YEAR 2022-23 BUDGET; PROVIDING FOR CONFLICTS; PROVIDING FOR SEVERABILITY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, Resolution No. 2022-091 appropriated funds based on an annual budget of estimated revenues and expenditures for the 2022-2023 Fiscal Year; and

WHEREAS, as of September 30, 2022, the available balance of Unassigned Fund Balance, Assigned Fund Balance or Unrestricted Net Position in all affected funds is expected to be in excess of the amounts required to fund the desired appropriations as shown in the attached Exhibit “A”; and

WHEREAS, the City Commission of the City of Wilton Manors finds that the additional appropriations of revenues and/or expenditures shown in the attached Exhibit “A” constitute a proper public purpose; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COMMISSION OF THE CITY OF WILTON MANORS, FLORIDA, THAT:

Section 1. The “WHEREAS” clauses are hereby ratified and confirmed as being true and correct and are hereby made a specific part of this Resolution.

Section 2. The Fiscal Year 2022-23 Budget for the Utility - Water Fund shall be increased by \$20,666; the Fiscal Year 2022-23 Budget for the Utility -Sewer Fund shall be increased by \$20,668, and the Fiscal Year 2022-23 Budget for the Drainage Utility Fund shall be increased by \$20,666; all by increasing the line items of the budgets as shown in Exhibit “A.”

1 **Section 3.** All Resolutions or parts of Resolutions in conflict herewith, be and the
2 same are repealed to the extent of such conflict.

3 **Section 4.** If any section, sentence, clause or phrase of this Resolution is held to be
4 invalid or unconstitutional by any court of competent jurisdiction, then said holding shall
5 in no way affect the validity of the remaining portions of this Resolution.

6 **Section 5.** This Resolution shall become effective immediately upon its passage
7 and adoption.
